ABSTRACT: Tooth Discoloration is commonly occurring abnormality in our day to day life. Porcelain Laminate is regarded as preservative option for clinicians. Central Dominance is an important element of an esthetic smile. This case report discusses a young individual desiring for change in his unpleasant esthetics. Laminates provides him better results for longevity above 21 years. Significance of porcelain laminates is economical, better aesthetics, less competitive, fewer appointments and prevents plaque accumulation.

Optimum aesthetics is visually pleasing and satisfying with proper functioning of dentition and masticatory system. A 25 year male reported to Department of Prosthodontics, GDC Patiala for discoloration of upper anterior teeth. He was not happy with his appearance. He informed of discoloration presence since birth. He desired for better aesthetics. Various modalities were discussed to patient which included laminate veneers, bleaching, composite veneering and micro abrasion but he selected option of a Porcelain Laminate.

As he hadunsastisfactory smile, thus to achieve proper functionality and better aesthetic rehabilation treatment was initiated .The shade was selectedunder direct sunlight with VITA 3D master

shade guide after doing impression. Color, form and size have been suggested as tools for assessing the dominance of maxillary teeth.

Depth orientationgrooves(Figure C) were placed on the facial surface of the tooth with0.3mm and 0.5mm three wheel diamond depth cutter on thegingival half and incisal half respectively.The

tooth structure remaining between the depth orientation grooves were removed with a round end tapered diamond.

Crown cutting was done followed by retraction with 000 ultrapack retraction cord.

Restored aesthetics as seen in view with Porcelain Laminates (Figure H). The results were welcomed by patient. It has minimal or no prepration of tooth being conservative in nature. Occlusion was checked to obtain no contacts on interfaces during function.

This treatment has been found to have longevity above 25 Years .It is better treatment option for young generation .Aesthetically pleasing results are available as treatment is stable, biocompatible,nonstainable,sustainable,satisfactory and feasible for all. The demand for this economical prosthesis is optimum as it is present in market since past.

Clinicians are well aware of fact that high bond strength is available without any sensitivity to provider. This report highlights significance of minimal thickness aesthetic rehabillation procedure. Proper technique with relevant skills and knowledge can bring wonders.
